* **Class A – Golf Course Superintendent.** To qualify for Class A membership, an applicant shall have, at the time of application, at least three (3) years experience as a Golf Course Superintendent and be employed in such capacity. Class A members shall have all the privileges of the Association.

* **Class SM – Golf Course Superintendent (Superintendent Member).** To qualify for Class SM membership, an applicant shall have completed, at the time of application for membership, less than three (3) years experience as a Golf Course Superintendent and be employed in such capacity. Class SM members shall have all the privileges of the Association.

* **Class C – Assistant Golf Course Superintendent.** To qualify for Class C membership, an applicant shall be, at the time of application for membership, an assistant to a Golf Course Superintendent, and shall be presently employed in such capacity. Class C members shall have all the privileges of the Association except that of holding office.

* **Class F – Associate Member --** To qualify for an Associate Membership, an applicant must be an employee of a business firm interested in golf course management and/or in the growing or production of fine turfgrass, either individually or through employment by, or other affiliation with, a company, proprietorship or association who does not qualify for membership in another class. This is not a company membership, but individual.
